**Declaration of specific undertakings**

We will observe the Code of Conduct of the FSM in its currently valid version and the decisions of the Complaints Committee as a matter of personal responsibility. We will abide by decisions and requirements expressed by the Complaints Committee against the company in case of an infringement of the Code of Practice, in particular the obligation to publish complaints in the telemedia product concerned. This declaration applies to all telemedia products of the company. We acknowledge the articles of association of the in the currently valid version as binding.

We will provide the Office of the FSM with a complete and comprehensive list of the websites for which the company is responsible or, as necessary, specific individual web pages, in the table in the accompanying Annex. We will inform the FSM Office immediately of any alteration.

We undertake to allow the FSM Complaints Service free access to the services for which we are responsible for purposes of control. Access or use of services in investigating a complaint or the activity of the FSM in performing its function as the provider of youth protection officer is free of charge for the FSM or we reimburse the costs of the FSM. We may not deny access to or information about our services to the FSM or otherwise impede access or acquisition of information.

We are aware that membership in the FSM commences only following a positive decision by the board.

**Declaration on assignment of the FSM as appointee for youth protection**

- Yes, we assign the duties of the appointee for youth protection in terms of § 7 JMStV to the FSM for the websites for which the company is responsible. We have fewer than 50 employees.
- We have less than 10 million visits on average per month. or  
 We have more than 10 million visits on average per month.

We declare that the services for which we are responsible have no content which contravenes the German law for protection of minors in the media or the FSM Code of Conduct. If we change the material we offer in future, we will involve the FSM as appropriate and in good time in question of creation, acquisition, planning and design of services and in all decisions concerning

protection of minors, and provide full information on the product concerned.

No, the FSM will not be assigned to be appointee for youth protection in terms of § 7 JMStV.


